### "Incoherence" Grand Rapids, MI 2024

- Discussion
  - o Can be good
  - Missed meaning/misinterpretation
  - Institutional obfuscations

- Re-writing narratives
- Making sense of knowledge claims
- Uncertainty and the grappling with "truth"
- What happens when Happy objects fail to fulfill us?
- Marginalized or silenced voices (made incoherent by structures or willful ignorance or biases)
- o When narratives (or voices, or truth, etc.) gets lost in translation
- Competing truths, or outdated "GRAND" theories that need to be updated;
  "RAPID" change that disrupts the narrative or truths
- Partner with Health COMM à Medical ethics and disinformation.
- Michigan State University, Oxford University (MI school shootings) Gun control movements and legislation (narratives, competing truths, etc.)
- Senate Bill 83 doing away with DEI offices, and/or banning critical race theory in schools
- Banning strikes (current events that seem to relate to the theme)
- Roe V. Wade, and state's reproductive rights laws à in Michigan (but probably elsewhere) there were a lot of political narratives that really obfuscated the issues, or CLAIMED that the other side was being intentionally misleading
- o Gen Z vs. Congress incoherence
  - § Tik Tok bans
  - § Messages being learned via Tik Tok examples (train wreck in OH being called mini-Chernobyl)
  - § Fake shootings on Twitter and Tik Tok/questions about the verification process on these platforms
