### **Report on 2024:**

- 14 papers submitted – co-sponsored 2 with argumentative division and undergraduate division (compared to 16 papers for 2023 conference)
- 2 panels submitted
- 7 sessions (compared to 12 sessions for 2023 and 3 sessions for 2022 conference)
- Submissions, from what Kristi knows, were down overall.
- Attendees of meeting were encouraged to visit the special exhibit: Activism on the Underground: Public History as Pedagogical Praxis. Highly interactive site in the history of the underground railroad, which was put together by undergraduate students.

**CSCA 2026 Conference Theme: Translate!** - How can educators bridge academia and activism through engaged pedagogy and partnerships with social justice organizations.

**Goals:** Continue to increase our submissions - Submission deadline is October 10<sup>th</sup>.

the translate theme (Making research more accessible to non-academic audiences, particularly communities who are the subjects of study).

4. Como Park Zoo & Conservatory: weatherproof enclosures, ethics of or lack thereof.
5. The Land of Ten Thousand Lakes/Water activism: Amount of fresh water it takes to cool serves; environmental racism; is anyone trying to build a cooling station?
6. BLM update: George Floyd update? Active chapter or memorial? Rhetorical construction of. Sites of racial healing.
7. Executive order to reinstate confederate monuments. Engaging in activism to protect those monuments that are counter to the racist ideologies that are inherent in confederate monuments.
8. Amy Aldridge Sanford: how do we translate messages of activism to resistant audiences? “Low walls among neighbors.”
